Directions to the Grounds: From the North/Atlanta - follow 75 south to 280 west. Go approx. 20 miles, bear left (South) on 195/118 toward Leesburg/Albany. Go about 10 miles, turn **RIGHT** (South) on 377. Entrance to trial grounds will be on your **RIGHT**. **From South/Florida** - follow 75 north to US-82 near Tifton. Turn Left (West) on 82 and follow all the way to Albany, GA. Go through Albany and on the north side, turn right (North) on US-19. Follow to Leesburg. In Leesburg, follow signs for Hwy 195 north. Follow 195 for 6 miles, turn Left on 377. Entrance to trial grounds is on your **RIGHT**.

Course is a one-hour single course. Approved tracking collars permitted, but not supplied.
