This year's running of the Quail Championship was scheduled at the Paducah Kentucky grounds but our date fell right before the VCA Nationals and many amateurs would not be able to get that much vacation in a row to be able to attend both events. So to accommodate the masses we were able to acquire a date at Pyramid Park two weeks earlier and thus moved the trial. Our plan is to return back to the famed Paducah Kentucky grounds the first week of November in 2012.

The Pyramid State grounds are the home of the German All Breed Championship each March as well as hosting the Egyptian Championship and the German Wirehair Nationals twice. On October 21-22, the Hoosier Vizsla Club will be running its AKC trial here and the VCA will be hosting its 2011 National Championship there in November. Also the VCOI will be hosting its fall trial there as well in September. So you will have the opportunity to run on these grounds twice before our NVA Quail Championship and the VCA Championship.

We are blessed to have the much respected Mr. John Burrows of South Fulton Tennessee returning to judge from last year. He is well known in the pointer community and has judged numerous championships. He actively runs shooting dog English Pointers. Our other judge this year is Guy Rezzardi from Luka, Illinois. Guy has campaigned GSP's for many years and has judged and help run the German All Breed as well as GSP Nationals.

The Super 8 in Pinckneyville will be the host hotel for the event. Entries may be turned in up until Saturday evening at the drawing at Alongi's Italian Restaurant in DuQuoin, IL. I prefer if you can, please send entries prior to me leaving by October 19th. A completed entry form with payment for each entry must be submitted or your dog will not be drawn. On Sunday October 23rd we will be starting at 8:00 AM and will be having our judge's dinner that night at the Grecian Steak and Seafood Restaurant in Pinckneyville.
